Dear Sir or Madam:

Thank you for requesting a plaque application. The purpose of the plaque is to promote identification and preservation of properties that add to the sense of time, place, and historic development of Selma and Dallas County.

The following plaques are available:

Blue: buildings constructed prior to 1865

Yellow: buildings constructed after 1865 and prior to 1910

Green: buildings constructed after 1910 and at least 50 years old

Of course, actual construction date is not the only information used to determine your plaque color. In the event that the building has been altered, its facade should be in accord with the building's original design. The facade or any addition should be in accord with the original structure design. If the addition is substantial in terms of area or architectural significance, the age of the addition shall control the plaque color determination. Buildings that otherwise satisfy established criteria may be ineligible if asbestos, aluminum, or vinyl siding has been added to exterior walls. Determination on such buildings will be made on a case-by-case basis.

The total fee for the plaque is \$50. Please send the non-refundable \$10 application fee along with your completed application. When approved, the additional \$40 will be payable upon receipt of your plaque.

The undersigned who are owners of real property located in Dallas County, Alabama, whose address is

hereby acknowledge and agree to the following:

1. The Selma Dallas County Historical Preservation Society (hereinafter referred to as "Historical Society"), is the owner of the plaque which bears its name which has been placed on the below-described property (hereinafter referred to as the "Structure"). All sums paid to the Historical Society at the time of receipt of the plaque or at the time my application for same was submitted, represent service charges and rental fees and do not give me any right of ownership in the plaque.
2. It is a privilege to be able to display the plaque upon the Structure.
3. The Historical Society shall have the right to set the standards and criteria for the displaying of the plaque.
4. If the exterior facade is altered in any way, including destruction by fire or other casualty, but excluding normal repair and maintenance, I will surrender the plaque to the Historical Society if it determines the Structure no longer meets its criteria for the display of said plaque.
5. In the event I transfer title to the Structure, I hereby agree to leave the plaque on display or will deliver same to the Historical Society.
6. In the event the plaque is stolen or destroyed by fire or other casualty, I agree to reimburse the Historical Society to replace the same if I desire a replacement.
